<b>First Time Affiliate</b>	<p>A person employed in local government or a relevant organisation* and has an interest in local government.</p> <p>A First Time Affiliate membership is at a discount rate, and lasts only one year. To continue with LGMA the member will need to become an Affiliate member in the following year.</p> <p>For example: Co-ordinators, Supervisor, Team Leaders, Policy or Project Officers, Administration Officers etc.</p>	\$90
<b>Affiliate</b>	<p>A person employed in local government or a relevant organisation* and has an interest in local government.</p> <p>For example: Co-ordinators, Supervisor, Team Leaders, Policy or Project Officers, Administration Officers etc.</p>	\$178
<b>Member</b>	<p>A person employed in local government or a relevant organisation* and works with or has an interest in local government.</p> <p>For example: Managers, Directors, Deputy CEOs and CEOs.</p>	\$513
<b>Fellow</b>	<p>To be a Fellow member an applicant should:</p> <ol style="list-style-type: none"> <li>(1) have made a significant and active contribution to LGMA or the local government sector; and</li> <li>(2) have held the status of Member of LGMA for a period of not less than ten years or such lesser period as may be approved by the Board; and</li> <li>(3) provide written endorsements from two current Fellows of LGMA.</li> </ol>	\$513
<b>Individual Subscriber</b>	<p>A person <b>not</b> employed in local government or a relevant organisation* who has an interest in local government.</p> <p>For example: Consultants.</p>	\$513
<b>Corporate Subscriber</b>	<p>A company, commercial business or other organisation that works with or has an interest in local government. This category includes membership privileges for two named company representatives.</p> <p>For example: Law Firm, Consulting Company.</p>	\$828
<b>Retired</b>	<p>A person retired from employment in local government who wishes to retain an interest in LGMA.</p>	\$97.50

\*A relevant organisation is determined by the LGMA Board. For example, it may include not-for-profit associations and community groups. It does not include companies or commercial businesses.

### Terms

- Membership invoices are automated on the 1st July each year and cover membership from 1st July to 30 June the following year. (Charged pro-rata quarterly in member's **first year**.)
- Invoices to be paid within 30 days.  
**Late payments may incur 2.5% surcharge.**
- If your Local Government pays for LGMA membership it is the responsibility of the member to ensure payment is made.
- If cancellation of membership is advised **within** 30 days of invoice being sent no charge will be levied for that year (LGMA to be notified of cancellation).
- Cancellation of membership **after** 30 days of invoice being sent, where payment has **not** been made to LGMA, will incur a monthly pro-rata charge.
- **No** pro-rata refunds will be made on cancellation of membership.
- It is the responsibility of the member to inform LGMA (in writing) of cancellation of membership.
- If your Local Government pays for LGMA membership it is the responsibility of the member to ensure membership is cancelled. Outstanding membership fees, at cancellation of membership, will be charged to the member.
- **Members are required to inform LGMA of any changes in circumstances** (e.g. changes to: job role; workplace details; home address and telephone details).
