

PAYMENT FOR EXHIBITIONS: Orders are only confirmed once all hire and other charges have been paid in full. No responsibility is accepted for non-delivery of goods where payment has not been made in advance or made available at the time of delivery.

PAYMENT FOR GENERAL HIRE: C.O.D. payment

GST: All prices exclude GST.

EQUIPMENT AVAILABILITY: All goods are subject to stock availability. Early Orders receive priority.

DELIVERY: Delivery takes place once the goods are loaded into the trucks leaving the factory to the destination of the exhibition.

CANCELLATION (INCLUDING FOR REASON OUTSIDE THE CONTROL OF GALAXY VISUAL DISPLAYS): Cancellation of orders occurring after the hire item has been loaded onto the truck or the purchase item been produced are due in full. Should the exhibition be cancelled for reason outside the control of Galaxy Visual Displays, hire items are due once delivery takes place. For items being produced (such as signage), such items are due before production and become the property of the exhibitor once paid. Should the order be cancelled after production of such items, they would be deemed property of the exhibitor and be available for pick up at Galaxy Visual Displays factory or made available for future use.

DAMAGE & LOSS: The Hirer shall at all times be liable for the willful loss of, or damage to the owners hire equipment from whatever the cause. Any damage from whatever cause must be reported to GALAXY VISUAL DISPLAYS immediately. (Phone: 08 9434 6222). GALAXY VISUAL DISPLAYS retain the right to remove goods at any time if the items are not being used for the purpose for which they were designed.

SPECIAL DELIVERIES: Outside our normal working hours special Transport rates apply. \$POA

TRANSPORT: Must be carried out by GALAXY VISUAL DISPLAYS Staff. An additional charge will apply for delivery and placement.

LATE ORDERS: Placed after the deadline will incur a surcharge of \$100.00 and be subject to availability.

ONSITE ORDERS: Will incur an additional \$100.00 surcharge and be subject to availability. Onsite Orders require full credit card payment. Credit Card surcharges apply.

ONSITE CHANGES: Any onsite request for alterations to electrical items will incur an additional minimum charge of \$25 per item. Onsite Changes require full credit card payment. Credit Card surcharges apply
